ENTRY DEADLINE:

All entries must be received or postmarked by **May 1, 2009**. Space is limited. Late entries will be accepted with a \$10 late fee space permitting. **No refund after the deadline. No entry will be accepted without an entry form.** Check www.indiacc.org/tabletennis to confirm your registration.

ELIGIBILITY:

All participants must be USATT or ITTF current members

FORMAT:

All singles will start with a round robin followed by a single elimination playoff. Doubles are single elimination.

EQUIPMENT:

Orange 3-star Nittaku premium balls supplied by Paddle Palace and ITTF approved tables. ITTF approved Stag floor mat on all courts.

ENTRY FEE:

\$25 for the 1st singles event. \$20 for the 2nd singles event. \$15 thereafter. \$20 per doubles event per team.

RULES:

- ① All USATT regulations, including equipment, conduct, dress, and language apply.
- ② All matches are best of 5 games to 11 except Open Singles semi-finals and final which are best of 7 games to 11.
- ③ There will be no gluing at the venue. It is recommended that players come with two legal rackets and two distinctively colored shirts..
- ④ Players must register at least 30 minutes before their starting time.
- ⑤ Ratings in the March/April 2009 USATT Magazine will be used to establish eligibility. The most recent rating will be used for seeding. Estimated ratings for new players will be accepted from USATT certified coaches. Unrated player may or may not advance from the preliminary round robin decided by the tournament director.
- ⑥ 3700 doubles event: all participants must be rated under 2100 (NO unrated players)
- ⑦ Players entering the Over 40 event must be over 40 years of age by June 1, 2009.
- ⑧ Juniors must be under the age of their event on June 1, 2009.
- ⑨ All decisions of the tournament referee will be final.
- ⑩ Prize money will be forfeited if the final is not played unless approved by the tournament director.
- ⑪ Events may be canceled or combined if needed. Fees will be refunded if canceled.
